Context

- Local needs – Hungarian and Central European students targeting international universities (red brick)
- Euroexam's response to local needs – a newly developed exam within the existing portfolio
- Levels of localisation (O'Sullivan & Dunlea, 2015)


Euroexam International exam portfolio

- General English exams (A1-C1)
- English for Business (Euro Pro B1-C1)
- New development: English for Academic Purposes – C1
 - Construct – level testing, oral and written exams
 - Skills tested – L – 3, S – 3, R – 3, W – 2
 - Validity

Research-based exam development

- Aim: to establish the validity of a locally-developed EAP test
- Method: mixed-methods research (Bachman & Palmer, 1996; Kim, 2011; Lukácsi, 2018; Read, 2015; Struthers *et al.*, 2013; Weir, 2005)

Stages of development



Test taker performance: Candidates and raters

- Candidates: immediate recall
 - perceived success *vs.* reported score
- Raters: think-aloud rating
 - impression *vs.* reported score

Test taker performance: Writing

Overall results

Observed data	Pass	Fail	Total
predicted* pass	57	23	80
predicted* fail	23	27	50
Total	80	50	130

Expected data	Pass	Fail	Total
predicted* pass	49.2	30.7	80
predicted* fail	30.7	19.2	50
Total	80	50	130

$\chi^2=8.28$

Writing results

Observed data	Pass	Fail	Total
predicted* pass	20	29	49
predicted* fail	32	49	81
Total	52	78	130


Expected data	Pass	Fail	Total

predicted* fail	32.4	48.6	81
Total	52	78	130



Rating on a checklist

- Judging a person in relation to a list of points deemed to be relevant for a particular level or module. (CEFR, 2001, p. 189)

■ Speaking means	61.4915	57.9322
■ Speaking pass rate	57.6271	45.7627
■ Complex exam means	63.2915	62.4949
■ Complex exam pass rate	59.3220	59.3220
